PRIVACY POLICY ex Art. 13 of the Regulation (EU) 2016/679

Dear Sir / Madam,

We wish to inform you, as Data Controllers, that the Regulation EU / 2016/679 General Data Protection Regulation (G.D.P.R.), of immediate application also in Italy, in anticipation of the issuing of the Decree required by the EU Law n. 163/2017 provides for the protection of people and other subjects with regard the processing of personal data.

According to the law, the processing will be based on principles of correctness, lawfulness, transparency and protection of your privacy and your rights.

According to the Art. 13 of the G.D.P.R., I therefore provide you with the information listed below:

- 1. a) Personal Data and contact details provided by you will be processed for the following purposes based on your consent and on the legitimate interest of the this company S.S.D.r.l.:** inclusion in the register of members and related membership at the National Educational Sports Center through the Peripheral Committee to which we are affiliated and any other use pertaining to the aforesaid associative and membership sports reports. The Data will be collected to be communicated to the Italian National Olympic Committee for the purposes of processing of the Company Register Sports for the fulfillment of constitutional obligations. **b) Furthermore, on specific consent, Data may be processed for communications for the promotion and dissemination of sport by the Italian National Olympic Committee.**
- 2. The legal basis for this operation** is art. 36 c.c., the tax regulation related to non-commercial entities, in particular art. 148 of the Consolidated Tax Act Article. the art.4 of the Decree of the President of the Republic 633/72 and the art. 90 of the Law 289/2002, as well as the rules of CONI and Federal Regulations, concerning the membership and the participation in the activities organized by these bodies or with their participation.
- 3. The legitimate interests of the Data Controller** pursued with this activity are a clear and correct application of the statutory provisions on the internal legal system and the administration of the association, the possibility to take advantage of the tax benefits of the association, the possibility to participate in the activities organized by the entities mentioned in the previous point 1.
- 4. The processing will be carried out in these ways:** through manual cards, created with the help of electronic means, stored in closed places, whose key is held by the President and by the staff in charge of the administration, or in a computerized way, on a PC placed at the headquarters of the Association, that is adequately equipped against information risks (firewall, antivirus, periodic backup of some data); authorized to access these Data are the President and the staff in charge of the administration. According to the art. 4 n. 2 of the G.D.P.R., the processing of Personal Data may consist in the collection, registration, organization, consultation, processing, modification, selection, extraction, comparison, use, interconnection, blocking, communication, deletion and destruction of data.
- 5. Personal data will be kept** for the entire time necessary for the correct keeping of the members book and / or to proceed with the formalities required by the National Educational Sports Center to which we are affiliated. The verification of the obsolescence of the Data processed with respect to the purposes for which they were collected and processed is carried out periodically.
- 6. The provision of Data is mandatory** for the achievement of the purposes of the Articles of the Statute of the Company and is therefore essential for the acceptance of your application for admission to a member and / or for membership at the staff indicated in the previous point; any refusal to supply them implies the impossibility of accepting your application for registration and / or membership, as in such hypothesis it will not possible to establish the indicated membership relationship at the National Educational Sports Center and the registration at the CONI Register.
- 7. The Personal Data can be communicated** to the National Educational Sports Center to which we are also affiliated through its peripheral bodies; all Data will not be disclosed to other subjects, nor disseminated.
- 8.** The processing will not involve Personal Data that belong to the category of "sensitive" data, i.e. "Personal Data suitable to reveal the racial and ethnic origins, religious beliefs, philosophical beliefs, political opinions, membership of parties, trade unions, associations or organizations of a religious, philosophical, political or trade union nature, as well as Personal Data revealing the state of health and life sexual health." Health data, if mandatory and imposed for insurance and legal purposes, are kept by the company doctor that provides for their process.

At any time you can exercise your rights** to know your data, to know how they were acquired, to check if they are accurate, complete, updated and well kept, to receive data in a structured format, commonly used and readable by an automatic device, to revoke any consent given regarding the processing of your Data at any time and object in whole or in part, to the use of the same according to the articles from 15 to 20 of the G.D.P.R. These rights can be exercised through specific instance addressed by registered mail - or PEC - to the Data Controller.
- 11. You have the right to withdraw your consent** at any time without prejudice to the lawfulness of the processing based on your consent before the revocation. This right can be exercised by sending consent revocation to the e-mail address indicated in the previous point 10.
- 12. You have the right to lodge a complaint** with the Guarantor for the protection of Personal Data or to the different supervisory authority that should be established by the envisaged Decree of the EU Law n. 163/2017.
